**Terms and Conditions of Membership**

**MEMBERSHIP AGREEMENT** THIS MEMBERSHIP AGREEMENT (the "Agreement") is made and entered into on the date specified on the face of this contract (the "Effective Date"), by and between Forest Waters Lodge, Inc., a Texas non-profit corporation d/b/a Forest Waters Club (the "Club"), and the person(s) whose name appears on the face of this contract ("Member"). WITNESSETH: WHEREAS, the Club maintains a private Health and Social Club at 21320 Water Wood Drive in Garden Ridge, Texas; and WHEREAS, the Member desires to use the facilities and equipment available at the Club; NOW, THEREFORE, for good and adequate consideration, the receipt and sufficiency of which is hereby acknowledged, the parties hereto agree as follows:

**Membership Fees**

Equity Member Initiation Fee: Negotiable (One-Time)  
Equity Member Transfer Fee: \$250.00 (One-Time)  
Associate Member Initiation Fee: \$100.00 (One-Time)  
Associate or Equity Monthly Membership Dues: \$80.00 (2010)  
\$85.00 (2011)

All of the above items are assessed state sales tax of 8.25%.  
Monthly membership dues (including tax) are currently \$86.60.

**The Club reserves the right to increase monthly membership dues at any time with 30 days written notice to the Member.**

**I UNDERSTAND THAT, IN THE EVENT OF DEFAULT, FOR ANY REASON, I THE MEMBER WILL BE RESPONSIBLE FOR ANY AND ALL ATTORNEY FEES, COURT COSTS, AND COLLECTION FEES.**

Initially, this contract is for the term specified on the front side of this contract. After the initial obligation has been satisfied, a member can resign by providing a minimum of thirty (30) days written notice and full payment of any outstanding dues and charges to the Club at that time.

Member bills are prepared on the first working day of the month and are payable in full no later than the 15<sup>th</sup> day of each month, either by check or recurring bank draft or credit card charge. Payments may also be dropped off in person at the Club or deposited in the drop box outside the Club office. Accounts in arrears for more than thirty (30) days will receive a past due notice; after sixty (60) days in arrears, members may be terminated and any outstanding financial commitments are payable in full, plus late, legal, and/or collection fees as appropriate.

Members may charge food and beverage items and/or various other Club activity fees to their member account. Member agrees that all charges for these items or fees will be included on their monthly bill and paid when their next regularly scheduled monthly bill is due.

All guests must be signed in and the sponsoring member must be present. The guest fee per day is \$5.00 per guest. Only non-local overnight guests of the sponsoring member will not be charged the guest fee; all persons using the Club (including the Member and guests) must sign in. Members may not pay cash for their guest fees; they must be charged to their member account. Children under the age of 15 years cannot sign in a guest without their parent's permission. Children under the age of 16 years cannot swim unattended by a parent or guardian or use the fitness equipment in the health club.

Forest Waters Club reserves the right to suspend or expel any member or guest from the Club either temporarily or permanently if their account becomes delinquent or inappropriate behavior occurs while at the Club. The Club Manager and/or Board of Directors have sole discretion on these matters. All members and guests must abide by all posted rules and policies. Forest Waters Club, its Management, Board and Equity Members are neither responsible nor liable for accidents resulting in injury or death to any member or guest of Forest Waters. A copy of the Club's By-laws will be provided to any Member within 72 hours of a written request.
